# DIRECTIONS FOR USE

CITRUS: 2 qts. per acre in intervals of 2-3 weeks as needed.

MELONS, PUMPKIN, CUCUMBER AND OTHER CUCURBITS: 1-2 qts. per acre. 1-3 applications in pre-flowering.

**LETTUCE, CELERY, CABBAGE, LEAFY GREENS**: 1-2 qts. per acre before thinning. Repeat the application after 2 weeks.

TOMATO, CHILI, PEPPERS, POTATO AND EGGPLANT: 1-2 qts. per acre in 2 post-flowering applications.

ONION AND GARLIC: 1-2 qts. per acre, in 1-4 week intervals during the growing season.

**GRAPES**: 1-4 qts. per acre. Begin first application when the first shoots have 4-6 leaves. Repeat applications as necessary.
