GENERAL INFORMATION

COMPATIBILITY: Ferti-POP 7-26-3 may be applied separately or in conjunction with most pesticides and with other fertilizers. The addition of a surfactant or wetting agent is recommended for improved coverage and penetration. A compatibility test is recommended if the desired combination has not been previously used. In this situation, before general applications, apply the spray solution to a small test area of the foliage to determine any undesirable phytotoxic effects.

SUGGESTED APPLICATION RATES

SOIL APPLICATION: Apply 2-4 qts. per acre at planting as a "pop-up" fertilizer.

COTTON: Foliar Application: Apply 1 qt. per acre in a band over the row in sufficient water for coverage. Use 2-3 qts. per acre in a broadcast spray. Repeat in 10-14 days. Maximum of 4 applications.

VEGETABLES: Use 1-4 qts. per acre depending on timing and plant requirements. First application should be made prior to flowering and/or fruiting. Continue throughout season at 7-10 days along with regular spray program.

OTHER CROPS: Use 1-4 qts. per acre starting no later than first bloom or fruit stage and continue every 10-14 days along with regular spray program.
