## Dry Water Soluble Fertilizer

**COMPATIBILITY:** Utilis Phos + may be applied separately or in conjunction with most other fertilizers. A compatibility test is recommended if the desired combination has not been previously used. Do Not use this product with ammonium thiosulfate, potassium thiosulfate or other high pH or high free ammonia products. When mixing with UAN solutions, add 1 gal. of water for every 1 gal. of UAN solution and blend well before adding Utilis Phos +.

**DIRECTIONS FOR USE:** Use in accordance with the recommendations of a qualified individual or institution or according to an approved nutrient management plan.

**WARNING:** This product contains boron. Over application or excessive use of boron can result in boron toxicity causing foliar damage or serious plant injury.

**MIXING INSTRUCTIONS:** Dissolve the recommended amount of Utilis Phos + into the required water maintaining constant agitation and recirculation. Water quality and temperature will determine the maximum solubility.

**RATE RECOMMENDATION:** Dissolve 5-30 lbs. in sufficient water to treat one acre. Add, but do not exceed 1lb. of Utilis Phos + per gal. of water. Repeat applications as necessary.
