SmartLine Pur-Spred improves performance of the active spray ingredients by providing more uniform distribution and better wetting of the plant surface.

Use Rates

Post-emergence herbicides, desiccants, defoliants:

1 to 4 pints per 100 gallons (0.125% to 0.500% v/v) spray solution.

Fungicides, insecticides, acaricides, miticides:

4 to 8 fluid ounces per 100 gallons.

Unless instructed otherwise by accompanying pesticide label, add SmartLine Pur-Spred as the first component to the spray tank.
